Coshocton City Council

Meeting Held: January 27, 2025

The Committee Meeting started at 4:00pm

Council President Hilgenberg went over the agenda for today's meeting.

He also inquired if there were going to be any Ordinances for the next meeting which will be February 3, 2025. Dave Kadri, Utility Director said he will possibly have two Ordinances. One for the OPWC loan for the Buena Vista water line and one with appropriations.

Assistant Service Director, Beaumont, will have two as well, one Resolution for the Internet Auction and one Ordinance for the chemicals that we purchase yearly.

Service Director Crown thought we needed to talk about the issues that came up at the last meeting regarding chickens. Council Member Moore asked if we knew if Mrs. Miletta has spoken with her neighbors to see if they had any problems with her having chickens in the neighborhood, also questions regarding the bird flu.

Mayor Mills said he had spoken to the new Sheriff regarding golf carts at the trailer parks. Sheriff Walters is not in favor of legalizing them.

Council Member Turner went over the issues about changing the terms of council. She will research an Ordinance and get with Law Director Skelton.

Council President Hilgenberg asked if there were any Committee Reports. There were none.

Mayor Mills informed the Council that they will be awarding the bids on February 5, 2025, for the Warsaw Water Line.

Service Director Crown reported that the Street Department has been working on potholes. Chestnut Street water line project has been not going as quickly as they thought due to weather conditions. Ask the public to be patient. Officially it should be done at the end of March.

Council Member Gross asked who is responsible for maintenance on the Memorial Clock on Main Street. SD Crown will have the City look at it.




